Message from our CEO

Craig Gates

For 80 years, Hill County Electric Cooperative (HCE) has been a cornerstone of rural life, a testament to the power of community and a steadfast commitment to serving its members. From humble beginnings in a courthouse basement, HCE's journey reflects the dedication and vision of its early members, who sought to create a better future.

HCE was officially organized in October 1945 and founded the following month. Just months later, on April 19, 1946, the cooperative received its first loan from the Rural Electrification Administration (REA), followed by a second loan on November 14, 1946, to continue its expansion. Many of our early members still fondly refer to HCE as the local REA, recognizing the funding source that helped bring electricity to their communities.

Progress moved swiftly. On December 10, 1946, survey crews began their work, and by December 23, construction was underway. Within a year, 60 miles of energized lines were serving 35 excited members. By 1948, HCE had completed and energized 400 miles of line, extending power to rural schools. By December 1969, the cooperative had expanded to 3,120 miles of pole lines, and by 1982, it was serving over 3,000 meters, an impressive feat given the equipment and technology available at the time.

In HCE's early years, employees went beyond just providing power, they also educated members on how to use their new electric appliances. Demonstration appliances were available in the office, helping members make the most of their newfound access to electricity. As the cooperative grew, so did the need for space. In May 1951, HCE moved into a new office building at 109 W 2nd Street. Then, in 1976, the cooperative relocated to its current headquarters at 2121 US Highway 2 NW, where it has continued to expand over the years.

The early years were not without challenges. HCE faced equipment shortages, an inexperienced workforce, harsh seasonal weather, and the complexities of trenching underground lines. Even now, 80 years later, challenges persist, but just as in the beginning, we work through them with the same determination and commitment to our members.

HCE's story is also part of the broader narrative of rural electrification in Montana. In 1967, the state had 24 Rural Electric Cooperatives serving 53,000 families. Today, the Montana Electric Cooperative Association (MECA) serves a vast network of 187,407 members, equating to 263,643 meters. Electric cooperatives across the state continue to play a vital role in providing reliable and affordable power to rural communities.

As Hill County Electric Cooperative celebrates its 80th anniversary, we take pride in carrying forward the legacy that began eight decades ago. From a small room in the courthouse basement to the location where we are hosting this year's Annual Meeting, our dedication remains unwavering. You, our members, are the reason we strive every day to provide the exceptional service you expect and deserve.

A heartfelt thank you to each and every one of you, especially to our current and former employees, whose commitment to service and safety has always been our top priority. Here's to the next 80 years!

- Passing upon reports of officers, trustees and committees for the year 2024.


• Transacting such other business as may come before the meeting and any adjournments thereof.




Use of Your 2024 - 2023 Electric Dollar

Summary

SECTION 3.03. Notice of Members' Meetings.

This proposed bylaw change is to increase the number of days for the notice of the annual meeting to be sent out. With the advent of mail-in balloting this requested change is to coincide with the notice and to allow enough time for mail in ballots to arrive and be returned. The board respectfully requests that you accept this bylaw change.

SECTION 3.03. Notice of Members' Meetings.

Written or printed notice stating the place, day and hour of the meeting and, in case of a special meeting or an annual meeting at which business requiring special notice is to be transacted, the purpose or purposes for which the meeting is called, shall be given to each member, either personally or by mail, not less than ten (10) days nor more than ninety (90) twenty-five (25) days before the date of the meeting. Such notice shall be given by or at the direction of the Secretary, or upon a default in the duty by the Secretary, by the persons calling the meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the member at such member's address as it appears on the records of the Cooperative, with postage thereon prepaid. The failure of any member to receive notice of an annual or special meeting of the members shall not invalidate any action which may be taken by the members at any such meetings.

(NEW) SECTION 3.03. Notice of Members' Meetings.

Written or printed notice stating the place, day and hour of the meeting and, in case of a special meeting or an annual meeting at which business requiring special notice is to be transacted, the purpose or purposes for which the meeting is called, shall be given to each member, either personally or by mail, not less than ten (10) days nor more than ninety (90) days before the date of the meeting. Such notice shall be given by or at the direction of the Secretary, or upon a default in the duty by the Secretary, by the persons calling the meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the member at such member's address as it appears on the records of the Cooperative, with postage thereon prepaid. The failure of any member to receive notice of an annual or special meeting of the members shall not invalidate any action which may be taken by the members at any such meeting.

Summary

SECTION 3.06. Voting List.

This proposed bylaw change clarifies when the complete list of members is compiled for both the annual meeting and mail in/online voting. The board respectfully requests that you accept this bylaw change.

SECTION 3.06. Record Date and Voting List.

A "record date" is the date for determining the total membership of the Cooperative and the members entitled to: (a) sign a member petition, request, demand, consent, appointment or similar document; (b) receive a mail ballot, notice of a member meeting or similar document; or (c) vote or otherwise act.

The Board may fix the record date, but such record date must not be more than forty-five (45) days before: (a) the date the first member signs a member petition, request, demand, consent, appointment or similar document; (b) the date a mail ballot, notice of member meeting or similar document is due or required; or (c) the date of a member meeting. Unless otherwise provided by the Board, a record date: (a) for signing a member petition, request, demand, consent, appointment or similar document, is the date the Cooperative receives the document; (b) for receiving a mail ballot, notice of a member meeting or similar document, is the date thirty (30) days before the document is due or required; and (c) for voting or otherwise acting at a member meeting, is the date fifteen (15) days before the member meeting.

The record date for determining the total membership of the Cooperative and the members entitled to notice of, or to voteat, a member meeting is effective for a member meeting adjournedto a date not more than 120 days after the original membermeeting date.

At least fifteen (15) days before the annual each meeting of the members, the Secretary shall make a complete list as of the record date, arranged in alphabetical order, of the members entitled to vote at such meeting and their addresses. Such list shall be produced and kept open at the time and place of the meeting and shall be subject to inspection by any member during the whole time of the meeting.

(NEW) SECTION 3.06. Voting List. At least fifteen (15) days before the annual meeting of the members, the Secretary shall make a complete list, arranged in alphabetical order, of the members entitled to vote at such meeting and their addresses. Such list shall be produced and kept open at the time and place of the meeting and shall be subject to inspection by any member during the whole time of the meeting.

<u>Summary</u>

SECTION 4.06. Nominations.

As the cooperative has found by doing mail-in balloting, it requires additional time before a meeting to prepare. To accommodate this additional time for those members who are running for a trustee position, the board is asking for those petitions to be received at least 90 days before the annual meeting. This gives those running the ability to petition and start running earlier than in the past and ensure that they are on the ballot.

The board wants to add a provision to protect the cooperative by making sure that the nominees can obtain Director and Officer (D & O) insurance if they are elected. The board is asking to add a felony conviction background check to trustee nominations before being placed on the ballot. The board requests to remove the printing of the nominee's addresses in the notice.

The board respectfully asks for your support of this bylaw change to help the cooperative have enough time for everyone who wants to run for the board and to give enough time for the mail-in process to work.

SECTION 4.06. Nominations.

Any fifteen or more Cooperative members, acting together, may make nominations by written petition containing the name(s) and address(es) of the nominee(s) and the District from which each is nominated, and the signatures, printed names and addresses of the petitioners. The petitioners must deliver the petition so that it is received at the Cooperative's principal office at Havre, Montana, not less than ninety days (90)forty-five (45) days prior to the annual member meeting. The Secretary shall post such nominations at the Cooperative's principal office. The Secretary shall mail, with the notice of the annual member meeting or separately, but at least seven (7) days before the date of the annual member meeting, a statement of the number of trustees to be elected from each District, the names and addresses of the nominees and the District from which each is nominated, if any.

All nominees must pass a background check for felony convictions prior to their name being placed on the ballot. The association will pay for and administer the background check.

Members may not nominate a person, even if otherwise qualified under Section 4.05 of these bylaws, to stand for election as trustee for more than one District at the same trustee election. No person may serve or be elected to serve as trustee for more than one District at the same time.

(NEW) SECTION 4.06. Nominations.

Any fifteen or more Cooperative members, acting together, may make nominations by written petition containing the name(s) and address(es) of the nominee(s) and the District from which each is nominated, and the signatures, printed names and addresses of the petitioners. The petitioners must deliver the petition so that it is received at the Cooperative's principal office at Havre, Montana, not less than ninety days (90) days prior to the annual member meeting. The Secretary shall post such nominations at the Cooperative's principal office. The Secretary shall mail, with the notice of the annual member meeting or separately, but at least seven (7) days before the date of the annual member meeting, a statement of the number of trustees to be elected from each District, the names and addresses of the nominees and the District from which each is nominated, if any. All nominees must pass a background check for felony convictions prior to their name being placed on the ballot. The association will pay for and administer the background check.

Members may not nominate a person, even if otherwise qualified under Section 4.05 of these bylaws, to stand for election as trustee for more than one District at the same trustee election. No person may serve or be elected to serve as trustee for more than one District at the same time.

Draw Scholarships


